#### MCJA asked April to give advice to new officials and to new mentors

Advice for **new officials**...mentor a couple of times to get into the rhythm of how the meets are run. Be prepared. Tab your book so you have information at your fingertips. The hardest part sometimes is when you know a rule but can't find the rule to show a coach.

Advice for **new mentors**...Don't feel like you have to know it all to volunteer as a mentor. My mentee came up with a couple of good questions I had never thought of before and I told her that was a good question and one I hadn't come across and that before I gave her an answer I wanted to confirm with some other judges first. I think new judges keep us veterans on our toes because they see things with fresh eyes.

April is a great example for new safety officials! When she is not judging, she is a stay at home mom to Ethan, 9 and Sydney, 7. She also works part-time as a Promoter for the Body by Vi 90-Day Challenge. "The Challenge is helping me reach my health goals and I love that I can help others reach their goals," April told us. Whenever she has free time (which isn't often with 2 kids and their after school activities), April enjoys reading, teaching their dog Dakota tricks, and just hanging out with family and friends.
